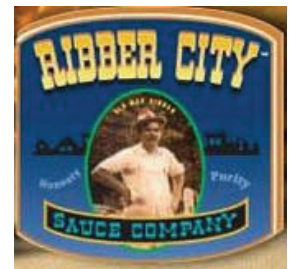

# 2009 Barnegat Fishin' Hole Fall Striper Tournament Rules & Regulations

1. At least one representative **MUST** attend the Captain's Meeting (Friday November 6th at 6:30 PM) to register and receive pertinent tournament information.
2. Tournament shall start immediately after the Captain's Meeting concludes.
3. Boats shall not fish for nor retain striped bass outside the 3 mile line.
4. **The Weigh Station will open from 12 to 3 pm Saturday.** No striped bass will be weighed prior to the scales opening. The weigh station will close promptly at 3 pm Saturday.
5. **Fish can only be weighed in by boat,** the official weigh station is Sun Harbor Bay Club.
6. This is a **Striped Bass ONLY tournament:** you may weigh your two heaviest fish, **all NJ and Federal regulations apply to size and bag limits.**
7. All striped bass, 28" and over will be judged by weight only.
8. All striped bass **MUST** be caught on rod and reel.
9. There will be a **maximum 6 anglers** per boat.
10. Please avoid established chum slicks and pass up wind of other fisherman.
11. Positively **NO TRANSFERING** of striped bass between vessels.
12. Boats may only weigh in two striped bass. It is the Captain's job to determine which two fish to weigh.
13. The Tournament Committee has the right to retain all eligible striped bass for internal inspection by the Tournament Committee.
14. VHF Channel 78 will be used for all tournament related communications. Please keep it clear. Channel 72 will be utilized as a first alternate.
15. **ALL CONTESTANTS PARTICIPATE, FISH AND SAIL AT THEIR OWN RISK!** The Captain and crew are solely responsible for deciding whether or not to fish.
16. Due to weather the Tournament Committee may cancel, postpone or extend the Tournament.
17. The Tournament may be canceled, postponed or extended to other dates by the Tournament Committee.
18. In the event that no eligible striped bass are landed, winners will be determined by a drawing from a hat. There will be no refunds.
19. **All Tournament Committee decisions are final.**
20. Every boat contending **MUST** be equipped with a working VHF radio and all USCG mandatory safety equipment.
21. Your Captain's Bag (received at registration) will contain an additional copy of these Rules and Regulations.
22. All contestants **MUST** read the rules and regulations and agree to abide by them.

YOU ARE THE OWNER/OPERATOR OF THE FISHING VESSEL IDENTIFIED HEREIN AND SPECIFICALLY CONFIRM TO BARNEGAT FISHERY HOLE AND TO THE LATTER'S INSURANCE CARRIER THAT YOU HAVE PROTECTION AND INDEMNITY INSURANCE COVERAGE ON THE VESSEL IDENTIFIED HEREIN AND THAT YOU SHALL PROVIDE THE NAME AND INSURANCE CARRIER, AS WELL AS YOUR POLICY NUMBER TO THE TOURNAMENT COMMITTEE UPON ITS REQUEST. YOU ASSUME ALL LIABILITY FOR THE ACTIVITIES AND PROPERTY OF YOURSELF, ALL YOUR CREW MEMBERS AND PASSENGERS, AND YOUR VESSEL. YOU WILL INDEMNIFY AND DEFEND BARNEGAT FISHERY HOLE AND EACH OF THE TOURNAMENT SPONSORS, AND EACH OF THEIR OFFICER, OWNERS, AGENTS AND EMPLOYEES, FROM ALL DAMAGES, INJURIES, EXPENSES (INCLUDING REASONABLE ATTORNEYS' FEES), LIABILITIES, JUDGMENTS, SETTLEMENTS AND COSTS ARISING OUT OF OR RELATED TO THE TOURNAMENT.
